#### Entry guidelines

#### 1)Paper size A3

2)Artistic medium: you may use colored pencils, markers, crayon, water paints or other similar drawing. All entries must be hand drawn. Works including, but not limited to, CG pictures made using a computer, collages, cut outs, etc. will not be accepted as entries. Any "collaborative works" completed by multiple individuals on a single piece of paper will not be accepted. All artworks must be in color with a background.

Any entry received without an entry form will not accepted. Please fill in all necessary items on the entry form, and securely attach to the back of your artwork. #### Judging

Judging will be strictly conducted in two stages:

#### Stage 1

Submitted artworks will first be judged at the" National Contest", with the top three artworks selected from each age category.

## Stage 2

In the World Contest, the Toyota Dream Car Contest judges will choose the outstanding artworks submitted from each country and select the Gold, Silver, and Bronze award winners, as well as the finalists. The results of the World Contest will be announced in June 2021 and posted on the global website for the Toyota Dream Car Art Contest: <a href="https://www.toyota-dreamcarart.com/top/">https://www.toyota-dreamcarart.com/top/</a>

Grand prize winners in each category (a total of three winners) and special award winners in all categories (two winners in total) shall receive an award certificate and prize money (intended for educational purposes). The school or college by which the winners attended at the time of entry shall also receive a "Supplementary Prize" consisting of \$5,000 to each individual winner and \$10,000 to each winner's school or college.

In light of the 2020 World Contest being cancelled, the winners of the 2019-2020 national contest will be entered into the 2021 World Contest.

#### Announcement of National Contest winners

The results of the National Contest shall be announced in March 2021 and will be posted on <u>https://www.toyotaghana.com/dreamcar.php</u>.

#### **Guidelines for World Contest Prize Money**
